North America Diving Dogs will be holding an all-breed dock diving event at the 2016 Crossroads of Ga Cluster. Dock diving is a fast-growing sport that is fun for dogs of all breeds and sizes. Titles are eligible for the AKC Title Recognition Program. Join the fun and excitement at this cluster and compete with your dogs for your titles or take the opportunity to try out the sport assisted by our experienced trainers. The event will start on Wed May 11th and will run until Sun May 15th.

Try-It Daily passes will be sold for **\$15.00** each day in order for new dogs to try out the sport of Diving dogs.

This event will have 15 diving Splashes and 3 Air retrieve splashes. Be sure to follow NADD for more information.

This event is a qualifying event for the 2016 AKC/NADD National Diving Dog Championships.

In order to qualify, each dog must have a minimum of 4 splashes completed at this event. We then take the average of all the jumps from the event for each dog. The TOP AVERAGE in each division will receive an automatic invite to the National Championships. (Note: If you receive an invite and at the time of Nationals your OVERALL average with NADD is in a different division than your invite, you will be moved to the appropriate division). Jumps in all the Splashes will count towards your NADD/AKC titles.

The Air Retrieve Qualifier will be held during the Saturday Air Retrieve competition. The top Finisher in the Senior, Master and Elite Division will earn invites.

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.



“DON'T FORGET TO CHECK THE OWNER-HANDLED BOX ON THE ENTRY FORM IF ENTERING THIS COMPETITION.”



All dogs that are owner-handled and are not solely owned or exhibited by professional handlers* meet the requirements for this competition. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner*. Professional handlers, household members and assistants to current professional handlers may not exhibit the dog in any breed competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are competing in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed, or in Best of Winners competition.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.*

THURSDAY 4-6 MO BEGINNER PUPPY JUDGING WILL BE HELD DURING LUNCH.

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event. Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show. The FSS competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.

Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- AKC registration number or an AKC litter number will be required for all entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the *Rules Applying to Dog Shows*.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.*

Entry Fee: \$12.00 (including AKC recording fee of \$2.00 for each dog. These fees are paid to the American Kennel Club.)

Entries will close Wednesday Noon, April 27, 2016 at Superintendent's office.

NON-REGULAR (ADDITIONAL) CLASSES Involving Multiple Dog Entries

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

BRACE CLASS - Two dogs of the same Breed or Variety of Breed with one or more common owner and at least one dog must be entered in another class.

The above classification is provided for all breeds (and varieties). Additional divisions, i.e. (age, color or weight) are in the breed list and must be indicated on the entry.

NOVICE JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

NOVICE SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN JUNIOR CLASS - For Boys and Girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN INTERMEDIATE CLASS - For Boys and Girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

OPEN SENIOR CLASS - For Boys and Girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present in the Novice Class.

MASTER CLASS - For Boys and Girls at least 9 and under 18 years of age on the day of the show and who have won ten (10) Best Junior Handler awards with competition. The calendar for this class will be consistent with the eligibility dates for the AKC Eukanuba National Championship. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

No exercise pens allowed in any building. No living rooms, no mats, crates must be stacked. No play pens or double strollers. No soft sided crates in grooming area.

Dogs allowed in rings during judging only, except in the designated practice ring.

Please observe all parking signs. Reserved & Handicap spaces MUST be used only by those with valid permits. Vehicles improperly parked will be towed.

No clickers allowed in the Obedience building.

The following breed may be judged on the table or on a ramp: Cardigan Welsh Corgis.

The following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). An AKC Recording Fee of \$3.50 1st Entry & \$3.00 additional entry of same dog will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3) These Fees are paid to the American Kennel Club.

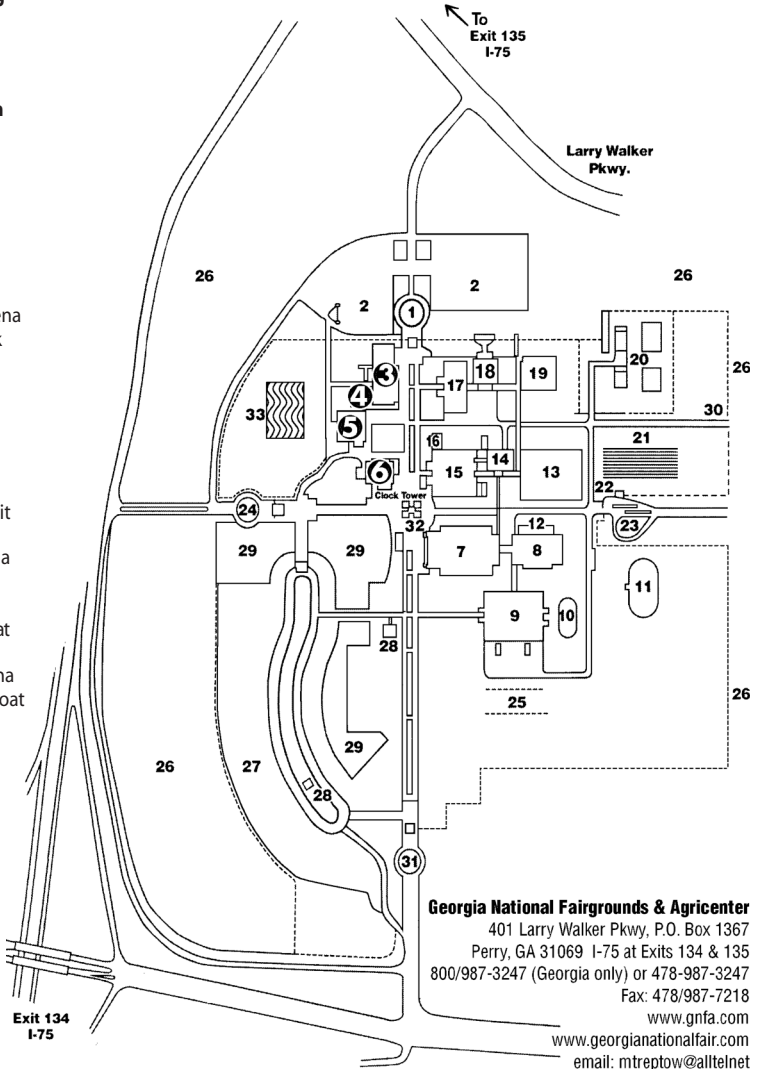

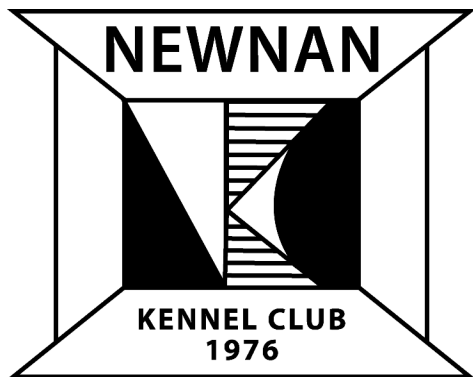

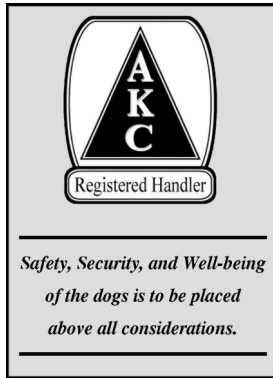
