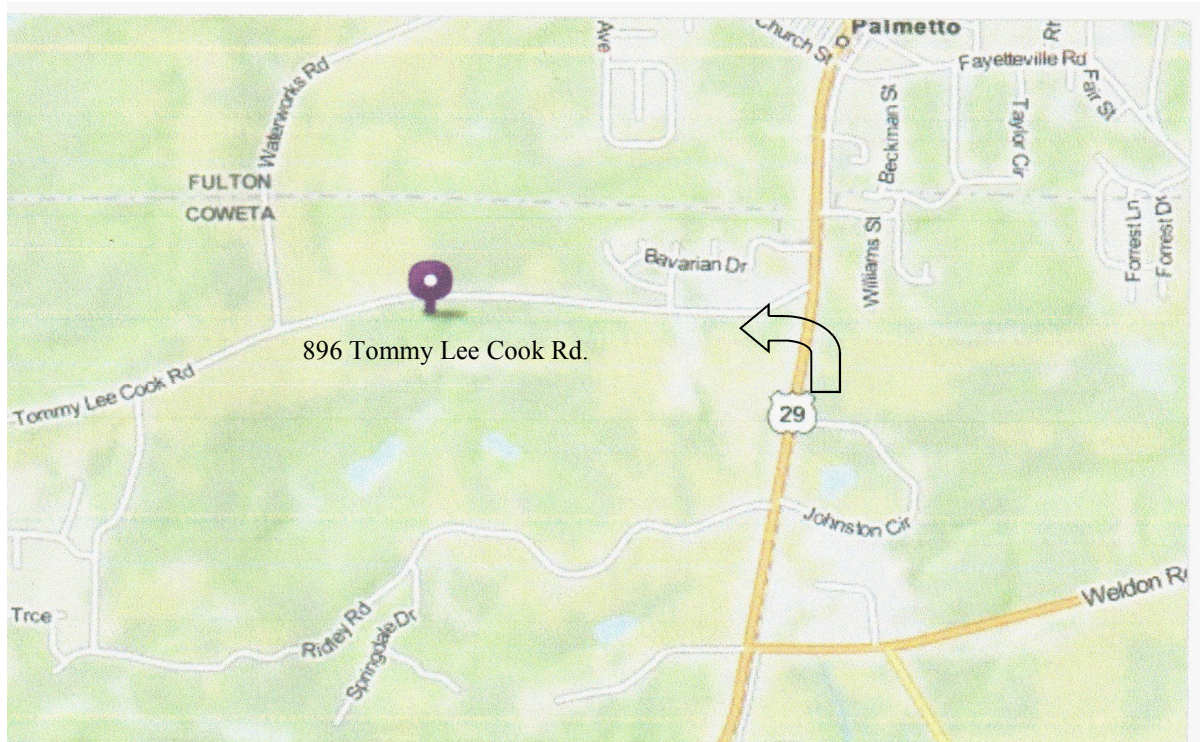
From his hometown newspaper:
