#### POSITION STATEMENTS

#### **BREED SPECIFIC LEGISLATION**

The Georgia Canine Coalition opposes legislation based on a particular Breed. The Georgia Canine Coalition does support education programs for the public concerning responsible dog ownership. The Georgia Canine Coalition does not believe that a dog should be declared a nuisance or a danger based on breed.

#### DANGEROUS DOG LAWS

The Georgia Canine Coalition does support enforceable, reasonable and non-discriminatory laws concerning dog ownership. The Georgia Canine Coalition believes in dog owners being responsible for their dogs. The Georgia Canine Coalition believes in a fair process to establish guidelines for defining "Dangerous Dogs" and a fair process for enforcing those guidelines. The Georgia Canine Coalition does recognize that there are times when it has been proven that a dog is "dangerous" and that it may need to be humanely destroyed.

#### LIMIT LAWS

The Georgia Canine Coalition does not support limiting the number of companion animals a person can own. The Georgia Canine Coalition does not believe that "limits" protect or serve to prevent any nuisance problems occurring because of dog owners who are not responsible for the dogs they own. The Georgia Canine Coalition believes that other ordinances are better suited to address nuisance problems.



#### MANDATORY SPAY-NEUTER LAWS

The Georgia Canine Coalition does not support mandatory spay-neuter. The Georgia Canine Coalition feels that mandatory spay-neuter laws do not have the effect of preventing unwanted litters. The Georgia Canine Coalition does believe in educational programs to educate the public about responsible breeding practices. The Georgia Canine Coalition does believe in educating the public concerning spaying and neutering pets.

#### **BREEDING RESTRICTIONS**

The Georgia Canine Coalition supports programs to educate the public about responsible breeding practices for purebred dogs and the also supports programs on being a responsible owner. The Georgia Canine Coalition supports reasonable and enforceable laws that protect both the health and welfare of purebred dogs as long as those laws do not restrict the rights of breeders and owners who are meeting their responsibilities as a reasonable breeder.

#### **HUMANE TREATMENT AND CARE OF DOGS**

The Georgia Canine Coalition believes that dog owners have a responsibility to provide proper care and humane treatment for their dogs at all times. This should include adequate and nutritious diet, clean water, proper housing and regular veterinary care.

#### **DOG FIGHTING**

The Georgia Canine Coalition opposes all forms of dog fighting, breeding for dog fighting and training for dog fighting. The Georgia Canine Coalition supported the strengthening of the Anti-Dog Fighting law in Georgia.

  - 1. KNOW THE BACKGROUND
    - a. WHAT CAUSED THE INITITIVE
    - b. WHAT HAPPENED
    - c. WHAT ACTION WAS TAKEN
  - 2. KNOW WHO INITITIATED THE ACTION
    - a. WHAT GROUP OR INDIVIDUAL
    - b. WHY
    - c. WHAT DO THEY EXPECT
  - 3. KNOW WHO INTRODUCED THE RULE, REGULATION, ORDINANCE, ETC. COUNCILMAN, COMMISSIONER, MAYOR, OR OTHER.
    - a. KNOW WHY
    - b. KNOW THE INDIVIDUAL WHO INITIATED THE REQUEST FOR ACTION AND THEIR RELATIONSHIP TO THE ISSUE.
    - c. KNOW THEIR POSITION RELATIVE TO THE GOVERNING BODY OR THE RESPONSIBLE AGENCY OR DEPARTMENT.
