

## First-aid Starter Kit





Keeping a first-aid kit close by can be handy in case your dog has an accident, gets a cut or eats something that could make it sick. The suggested materials listed below are intended to assist you with the basic first aid. If possible, always immediately contact a veterinarian when you suspect your dog is injured. He or she can guide you through the initial steps of basic first aid, such as slowing bleeding or inducing vomiting, until you can get to the veterinarian's office.

## First-aid Kit Checklist Your veterinarian's □ Eyedropper or large phone number syringe (without the needle) Gauze Towels or cloth Non-stick adhesive tape □ A board or large blanket Non-stick bandages to use as a makeshift Hydrogen peroxide stretcher

## KEEPING YOUR DOG'S TEETH CLEAN CAN HELP KEEP HIM HEALTHY!

Like your teeth, a dog's teeth need daily care to remain healthy and strong. One way to prevent your dog from getting tooth decay or oral disease is to brush his teeth daily with a toothpaste and toothbrush designed especially for dogs. Also feed him specially formulated foods proven to reduce plaque and tartar buildup.

Many dogs as young as age 3 may already show some form of oral disease. If left untreated, bacteria from the teeth and gums can cause serious health

problems. Visit your veterinarian regularly, especially if you see signs of possible oral disease, such as bad breath, yellow-brown crust around the gum line, pawing at the mouth, change of chewing or eating habits, subdued behavior, excessive dribbling, bleeding gums, pain when eating or tooth loss.
